

FRESNO HIGH SCHOOL SOBER GRAD 2018

GUIDELINES AND CONTRACT

1. The Sober Grad Party is for the current graduates of Fresno High School only.
2. Students will be required to show Photo ID to gain admission (photocopy of driver's license is recommended). Students will be asked to remove hats, outerwear, shoes, or boots and understand that backpacks/purses or other items in which to carry personal possessions are subject to search.
3. We are not responsible for any lost, damaged, or stolen property. There will be lockers available for cost of \$0.50 per use.
4. The possession or influence and/or use of drugs or alcohol by any graduate, party staffer or entertainer are not permitted. Parents/Guardians may be contacted if your student is suspected of being under the influence of alcohol or drugs and may be asked to come pick up the student. The senior may be held in an area separate from the party for observation. If Tribal Council Member or Tribal Council Volunteer feels the student should be sent home, ONE attempt will be made to reach the parent /guardian at the phone number listed on this form. If we cannot reach the parent /guardian at the phone number provided, we reserve the right to call the police or ambulance for emergency assistance depending on the severity and/or condition of the student.
5. Sober Grad party is 11:00pm to 4:00am (check-in 11:00pm-12:00am; no admittance after 12:00am)
6. Parents or Guardians of graduates will be called to pick up their student if the student wishes to leave the party before it ends to pick them up. Only the student of the parent /guardian will be allowed to leave with the parent /guardian. Students may not leave the party before it ends unless they are accompanied by their parent /guardian.
7. Students leaving the party (accompanied by their parent /guardian) will not be readmitted.
8. Students must be present to win raffle prizes at the end of the party.
9. All payments are **non-refundable**.
10. The Guidelines and Contract form must be signed by student AND parent/guardian (even if student is 18 years old) to participate in Sober Grad.

I/my child wish(es) to participate in Fresno High School Sober Grad. I/my child agree(s) to abide by the above guidelines for Fresno High School Sober Grad. I/we understand that Sober Grad activities and games are voluntary and that my/my child's participation in these activities is at my/my child's own risk. We understand that there are risks and dangers incidental to participating in this event and that there is a risk that I/my child could be injured. I hereby give my consent for me/my child to participate in this event and I/we, on behalf of myself/my child, assume the risk and dangers associated with my/my child's participation in this event. I/we hereby release Fresno High School and FHS Tribal Council Parent Club from any and all incidents in connection with activities and games.

I/we understand that I/my child may be videotaped or photographed at the party and that these videos or photographs may be used in future Sober Grad promotional materials. I/we further understand that students are allowed to bring cameras and cell phones with the capability to record activities to the event and that Fresno High School and FHS Tribal Council Parent Club has no control or responsibility over the release or use of the photos or videos taken and I/we agree to release and hold harmless Fresno High School and FHS Tribal Council Parent Club with respect to any photos or videos taken of me/my child while at the event.

In return for FHS Tribal Council Parent Club permitting me/my child to participate in Fresno High School Sober Grad, I/we hereby release and waive on my behalf, on behalf of my child, and on behalf of any persons claiming

by or through me, or my child, any and all claims or causes of action for ordinary negligence which I or my child may have against Fresno High School, Fresno High School Tribal Council, its officers, directors, agents, employees and volunteers arising out of or resulting from any and all injuries, accidents, illnesses or damages of any nature, including death, which I/my child may suffer while taking part in the event or any activity connected to the event.

IN SIGNING THIS DOCUMENT, I/WE ACKNOWLEDGE AND REPRESENT THAT I/we have read the foregoing Guidelines and Contract, I/we understand it and sign it voluntarily as our own free will: no oral representations, statements, or inducements, apart from the foregoing written Agreement, have been made; I (parent/guardian) am at least eighteen (18) years of age and fully competent; and I/we execute the Agreement for full, adequate, and complete consideration fully intended to be bound by same.
