

Online Registration for Preschool Students

Our Online Registration Tool is designed to streamline the registration process and save time. The registration can be completed from a cell phone, a tablet, or any other web-enabled device. It is available in three languages: English, Spanish and Hmong. Parents/Guardians will need to **upload** required documents to complete the registration process. The list of required documents can be found at earlylearning.fresnounified.org.

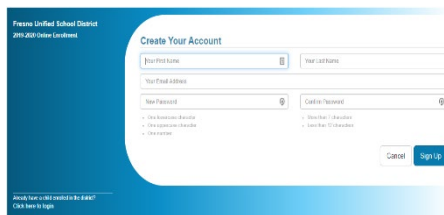
This tool is not for existing students transferring to a new school.

Parent Process:

- If you have a Personal Parent Portal Account in ATLAS click here: [ATLAS Parent Portal](#) and select Registration.



- If you do not have an existing Parent Portal Account, go to [Online Registration](#) to begin. You must have a valid email address prior to creating your personal account.



- Enter your child's address.

Getting Started

Step 1: Enter the address where your child currently lives

Note: your child must be 6 weeks or older. Children 6 weeks or older or less than 3 years old are eligible for full day program only.

If your child is 4 years old, you will be asked if you are interested in the Dual Immersion Program (DI). This is not applicable for 3-year-old children. Dual Immersion refers to teaching academic content in two different languages with the goal of students becoming literate in both. Some Dual Immersion and bilingual programs teach equally in two languages while others begin equally and gradually switch to mostly English.
